 We are currently finalizing the draft RFP for the THIRA expansion grant project.

- Beverly reported that the Committee met last Monday. We had planned to have our Regional CERT Exercise last weekend at Enon Training Center, but the event was cancelled due to the storm. We are hoping to reschedule it next year.

JIC and FAC are both hot topics we are yet to come up with a regional plan. Idea is to come up with commonalities of basic functions of JIC, regardless of the locality. Functions, positions, and specifics. We hope that everyone can participate in this process.
- The THIRA is a great resource for writing grants and plans. Most of our SHSP proposals require backup documentation – which would be a reference to the THIRA.

Chesterfield County (Emily Ashley) – Hosted evening for the community as "stress debriefing" event due to the weather events. Event was small attendance but impactful. We distributed a brochure that can be used for any type of disaster and would be happy to share.

CVHC (Steven Parrott) – Been busy at the RHCC during the hurricane events. Just conducted annual Stabilization and Treatment-in-place tent setup. We set that up over the last few days and did a complete inventory. This resource is out there and available.

VDU (Brian Pierce) - Looking forward to working with CVEMA.

Army National Guard (Cari Keslo) - There is a new training facility being built down at Fort Pickett. We expect to have 10,000 students in the facility.
