Call to Order

D. Approval of Minutes, March 10, 2005 Meeting

Ms. O'Bannon brought to the attention of the Commission that the FCC has posted its request for comments on any problems local governments had in obtaining radio air time to pass along emergency information to the public during recent natural disasters.
